- Provisional selection list to be published by Principal/Director of the Concerned Colleges/Deptt./Institutes : 01.07.2023
- Period of admission against selection list
 As per decision of concerned Colleges/Deptt./Institute.
 Session begins (Proposed)
 10.07.2023

1. N.B.:- Applicants are directed to procure the admission form from the Concerned Colleges/Departments/Institutes on payment of Cost by DD/NEFT and should apply as per schedule. Details can be seen at website of Concerned Colleges/Deptt/Institute. Admission process in both modes Offline/Online as decided by the concerned College/Deptt./Institute.

2. Admission may continue further if the seat(s) remain(s) vacant even after beginning of the session.

The Principals/Director of Constituent Colleges/Deptt./Institutes are authorized to follow the respective selection process of the courses. However, the selection list should be prepared in accordance to the Reservation Roster of State Government.
