 - Every student has the facility to apply in one or more subjects or more **(2)** than one College as per their choice using his/her single login on Chancellor's Portal.

Weightage allowed to applicants as per University & State Govt. Rules will be given during preparation of merit list. Principal/Prof In-charge are directed to follow the reservation policy of the State govt. The Caste certificate issued by the relevant authorities of the State Govt. will be valid for any claim. Certificate issued by any other authority outside Jharkhand will not be entertained. The original certificates will be physically verified at the time of admission. If an applicant fails to produce the original certificate then his/her claim will be rejected.
