Sub: - Regarding Subject mapping of Minor subjects as associated core in the Academic Session 2025-26 and onwards for the Four Year Under Graduate Programme (FYUGP) at Constituent and Affiliated Colleges under Ranchi University, Ranchi.

Madam/Sir,

As you are aware, admission in Undergraduate Regular Courses in colleges under Ranchi University, Ranchi, is proceeding for the four-year undergraduate program (FYUGP) 2025 under the provisions of NEP 2020. Many suggestions were received regarding the Subject mapping of the Associated Core with Major subjects. "NEP Implementation and Monitoring Committee" in its Meeting dated 04.07.2025 & 10.09.2025 resolved that:

1. The Subject mapping provided by the DHTE vide Memo No. 01/401-63/2021-223 dated 31.01.2023 (copy hosted at RU website) of Minor courses with Major courses may be allowed in first and second semesters along with other provisions of selection of elective subjects, as minor, described in the latest regulation notified vide memo no. RU/R/7763/25 dated 09.04.2025.
2. Minor and Major courses may be changed only once before the beginning of the 3rd Semester, depending upon the availability of seats, marks and the other criteria imposed by the institution. However, the student must clear the papers from the previous semesters of the new subject opted in the next examination of the coming session.
3. The University will offer the path for the Internship/Apprenticeship in the 5th semester as a component of IAP in the FYUGP curriculum implemented from session 2023 and onwards. Thus, the Project can be offered in the 5th semester at present. However, the project will be evaluated in the HEI in a similar mode of practical/ dissertation evaluation by the External and Internal Examiners.
4. The Head of the Institution will furnish a declaration in a prescribed format of "Eligibility of Institution to offer Honours with Research" before offering the Research options to the eligible students. The Hons with Research may be offered *only after the written approval of the University* for each subject every year. A maximum of 10% of the total seats per subject may be fixed for the Research courses to be offered every year.

This may be treated as most urgent.
